## Azarga Metals anticipating release of Unkur PEA next month

Dusty Nicol, president and CEO of Azarga Metals Corp (CVE:AZR), discusses with Proactive's Andrew Scott the recent resource upgrade for the Unkur copper-silver project in Russia - which lifted the size of the inferred resource by 47%.

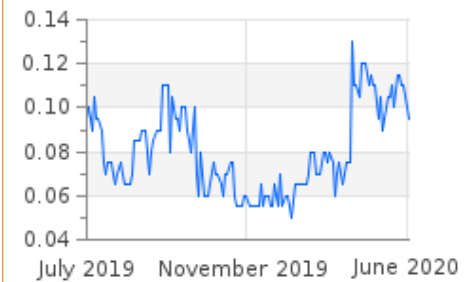
The latest report shows an inferred resource (lower confidence) of 62mln tonnes at 0.53% copper and 38.6 g/t (grams per ton) silver.

Azarga's recently received shareholder approval to increase its stake in the project to 100%.
