Namaste Technologies addresses recent challenges as they look to grow in the future

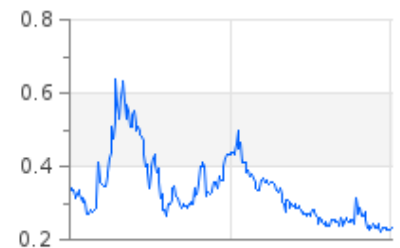
