Goldplay Exploration's San Marcial Project glitters as resource may double

Goldplay Exploration Ltd (TSXV:GPLY) (OTCQB: GLYXF) CEO Marcio Fonseca tells Proactive Investors the gold exploration company has drilled a high-grade gold intersection from its first core drill hole at its San Marcial Project in Mexico.

Fonseca says the Vancouver-based company has effectively defined a new gold mineralized zone close to surface, adjacent to the western edge of its resource at San Marcial. Fonseca says in the next 9 months, the company may be in a position to double the resource in the area.
