## Full interview: Australis Capital executive optimistic on SAFE Banking Act, talks through milestones in past year

Australis Capital Inc's (CSE:AUSA) (OTCMKTS:AUSAF) Senior Vice President of Investor Relations, Brent Reuter explains to Proactive how he believes, if passed into law, the SAFE Banking Act would benefit the business. The House of Representative is set to vote on the bill this week, which would allow financial institutions to serve cannabis businesses in states where it is legal.

Separately, Reuter says the company has been able to hit many of its milestones since listing on the Canadian Securities Exchange around one year ago, including making several acquisitions, and beginning to trade on the OTCQX Best Market having been upgraded from the OTCQB.
