## Buds & Duds: Analysts call for cannabis sector's bottom; stocks stay quiet

The North American Marijuana Index, which tracks the top cannabis stocks in the US and Canada fell 1.4% at 127.4 points. Elsewhere, the OTCQX Cannabis Index was up 0.4% to 446.5 points.

Buds were PharmaCielo Ltd (CVE:PCLO) (OTCMKTS:PHCEF), Mojave Jane Brands Inc (CSE:JANE) (OTCMKTS:HHPHF). Duds were TransCanna Holdings Inc (CSE:TCAN), Charlotte's Web Holdings Inc (TSE:CWEB).
