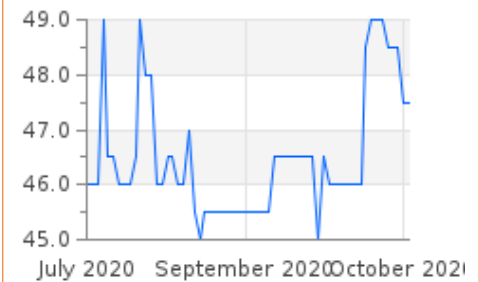
## AEX Gold is fully permitted and focused on getting its mine in Greenland into production in 18 months
