Gatling Exploration appoints industry veteran Jody Dahrouge to board of directors

Gatling Exploration Inc (CVE:GTR) (OTCQX:GATGF) announced Wednesday that industry veteran Jody Dahrouge has been appointed to the company's board of directors.

According to a statement, Dahrouge is a senior geologist and president of Dahrouge Geological Consulting Ltd, a geological services company that provides consulting services to a broad range exploration and mining companies worldwide.

Dahrouge is also the president of DG Resource Management Ltd, a project generator which has identified, acquired and advanced a number of gold projects throughout North America.

He is a professional geologist and has also been a director of several public companies exploring for and advancing gold projects throughout the Americas.

In other company news, Gatling said it has granted incentive stock options to directors, officers and consultants for the purchase of up to 1.9 million common shares at \$0.34 each for a period of three years, subject to the acceptance of the TSX Venture Exchange.

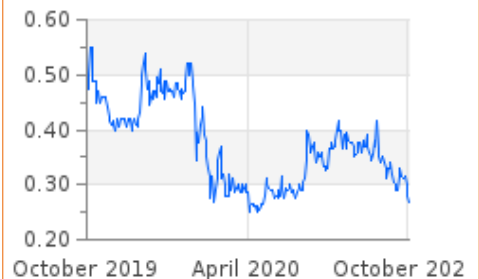
