Applied Graphene signs up Maroon Group as US and Canadian distributor

The agreement provides a direct route into the coatings and polymers sectors in North America said Applied Graphene, adding Maroon has been distributing specialty chemicals and ingredients across both countries since 1977.

Maroon will introduce Applied Graphene's graphene dispersions technology, **Genable** into the market, AGM said.
