RA International winning larger contracts and broadening its customer base

RA International's (LON:RAI) Andrew Bolter caught up with Proactive's Katie Pilbeam on the back of its interim results to June 2020. Among the highlights the company was awarded what it's described as a landmark \$60mIn commercial contract to provide services to a new global client in Southern Africa. The two-year contract is their largest deal since coming to the AIM market. They've also been appointed by Danakali Ltd (ASX:DNK) (LON:DNK) as the preferred supplier to construct a 1150-person camp facility and other infrastructure during the construction phase of its Colluli mine in Eritrea.
